### Please note the following:

- Each solicitor must provide a new FBI Criminal History Clearance at the time of application.
- Upon arrival each applicant must come to the Police Office and submit a picture I.D. which will be placed on their individual permit. Permits are to be carried at **ALL** times while soliciting in the Townships & Boroughs.
- All applicants must **STRICTLY ADHERE** to the Townships & Boroughs Ordinances and "**No Solicitation List.**"
- The fee for solicitation permits will be based upon the number of solicitors that the company is purchasing permits for. The below fees are total for the company and not per solicitor.
  - 1-5 solicitors = \$10 for permit(s)
  - 6-10 solicitors = \$20 for permits
  - 11-15 solicitors = \$30 for permits
  - 16+ solicitors = \$40 for permits
- Each person is required to have a "**No Solicitation**" List (A list of addresses in the Townships & Boroughs where the Resident has requested **NO SOLICITORS BE ALLOWED TO SOLICIT**) while soliciting. This is \$0.25 cents per page with the average cost being \$5.50 and each person must buy this list directly from the Police Department and sign acknowledging receipt of the list. This list must be purchased before a solicitation permit is issued.
- Each permit will expire in 30 days and will need to be renewed with a new application including criminal history and purchase of a new non-solicitation list.

In accordance with Peddling & Soliciting Ordinances for the Township of Pine, Marshall Township, Bradford Woods Borough and Richland Township: **LICENSEES SHALL BE PROHIBITED FROM OPERATING BEFORE 9:00 AM OR AFTER 9:00 PM ON MONDAY THROUGH SUNDAY, PREVAILING TIME. THIS WILL BE STRICTLY ENFORCED.**
