# NORTHERN REGIONAL POLICE DEPARTMENT JOINT POLICE BOARD MEETING MINUTES

Chief Sicilia explained that there has been a possible data breach nationwide and also fictitious unemployment claims.

Captain Bryan DeWick briefed the board on the following:

August 15, 2021 – A reported forcible rape at Jergel's parking lot.

August 19, 2021 - A gun stolen at Bobby Rahal's.

### **Old Business**

Chairman; Jason Bragunier and Victoria Laird-Pongrace discussed the need to finalize the Finance Committees list.

Discussion of Change Order regarding the fire suppression system in the locker room.

Chief Sicilia said the locker room project is over the general contractor came in with the final punch list. The architect will be in on Monday.

The existing component for the fire suppression system was not enough. A balance of \$4,003.26 is due. Plus roof damage to the Township of Pine building of \$700.00 from punctures one of the contractors made in the roof for a total of \$4,703.26 is due.

A motion by Victoria Laird-Pongrace, seconded by John A. Marshall, to pay the balance due of \$4,703.26 for the additional cost of the fire suppression system for \$4,003.26 plus the roof repair damage to the Township of Pine Building of \$700.00 to be paid out the of Locker Room Project Fund. The aye vote was unanimous. Motion carried.

Chief Sicilia pulled out the discussion of "Service Policy" with Township of Pine because of Township of Pine Manager, Jason Kratsas not having time to review it as well as the entire Pine Board.

Rich Miller said arbitration was awarded and can be released to the public but still would need to be discussed in Executive Session.
