# NORTHERN REGIONAL POLICE DEPARTMENT JOINT POLICE BOARD MEETING MINUTES

# Wednesday, March 23, 2022 Township of Pine Community Center

## Approval of Minutes from the February 23, 2022 meeting

Motion was made by Raymond Kendrick, seconded by Jack Candek to approve the minutes of February 23, 2022. The aye vote was unanimous with George Allen, Victoria Laird-Pongrace and John Marshall abstaining. Motion carried.

#### Chief's Reports

Discussion took place. Pasquale Avolio requested a motion to approve Chief Sicilia's February report. Ryan Colombo made a motion to approve, seconded by Casey White. The aye vote was unanimous. Motion carried.

  - Buchanan Ingersoll & Rooney, P.C.- Proposal for Solicitor and Labor Council
  - Babst Calland Clements & Zomnir, P.C.- Proposal for Labor Counsel only

Chief Sicilia suggested representatives from each law firm attend the April board meeting to be interviewed by the Board members.

Discussion took place. Pasquale Avolio requested a motion to interview representatives from the law firms Campbell Durrant and Buchanan Ingersoll & Rooney. Casey White made a motion to approve, seconded by John Marshall. The aye vote was unanimous. Motion carried.

- Update on Agreement to Provide Administrative Services between NRPD and Township of Pine (pending review by the Chief of Police and Managers). – Chief Sicilia indicated he and the Managers would like to table discussions of Old Business items 2 and 3 until a Solicitor and Labor Council are appointed. - Continuation of discussion of the Formation of an Ad-hoc Strategic Review Committee to explore the varying needs of the constituent communities. – Discussion ensued. Item will remain under Old Business for future discussion.

 Consideration of Resolution 2022-2 "Heart and Lung Act Policy". - Chief Sicilia stated that Resolution 2022-2 "Heart and Lung Act Policy" was reviewed and approved by attorney Julie Aquino. Discussion ensued.

Pasquale Avolio requested a motion to table Resolution 2022-2 "Heart and Lung Act Policy". George Allen motioned to table, seconded by Victoria Laird-Pongrace. Motion rescinded.

George Allen made motion to approve Resolution 2022-2 "Heart and Lung Act Policy" with amendments providing the definition of the HLA panel, a Request form for HLA and a Termination of HLA Benefits form, seconded by John Marshall. The aye vote was unanimous. Motion carried.

Consideration of Resolution 2022-3 "Restatement of Non-Uniform Pension Plan". – Pasquale Avolio requested a motion to approve Resolution 2022-3 "Restatement of Non-Uniform Pension Plan". Ryan Colombo motioned to approve, seconded by Casey White. The aye vote was unanimous. Motion carried.
