NORTHERN REGIONAL POLICE DEPARTMENT JOINT POLICE BOARD MEETING MINUTES

Wednesday, September 28, 2022 Township of Pine Community Center

The meeting of the Northern Regional Police Department Joint Police Board was called to order at 7:01 P.M. by Chairman, Pasquale D. Avolio.

- 5. Motion to approve the return of \$200,000 attributable to the 2021 operating surplus to each municipality based on the 2021 contribution ratio. The October 2022 municipal contributions will be reduced as follows:

Pine: \$74,260

Marshall: \$54,040

Bradford Woods: \$8,000

Richland: \$63,700
