# NORTHERN REGIONAL POLICE DEPARTMENT JOINT POLICE BOARD MEETING MINUTES

# Wednesday, October 26, 2022 Township of Pine Community Center

The meeting of the Northern Regional Police Department Joint Police Board was called to order at 7:02 P.M. by Chairman, Pasquale D. Avolio.

Members in attendance were Chairman; Pasquale D. Also in attendance were Chief John Sicilia, Captain Bryan DeWick, Solicitor Julie Aquino, and Solicitor Jonathan Whalen. Treasurer Jan Kowalski was not in attendance.

## Presentation of grant from Representatives of the Officer Brian Shaw Foundation

Prior to the presentation of the grant, Chief Sicilia introduced the representatives in attendance from the Brian Shaw Foundation; Lisa Shaw, Steffan Shaw, and Jaclyn Shaw. Chief Sicilia spoke about Brian Shaw's career in law enforcement and how Brian's legacy of service continues through the grants and scholarships provided by the Brian Shaw Foundation.

Chief Sicilia explained how the \$15,000 granted by the Brian Shaw Foundation will be used by the Northern Regional Police Department to purchase and train a new service dog for the department. The new K-9 will be used primarily for tracking purposes, which will be of great benefit to the communities served by NRPD, especially the autistic and elderly populations.

Pasquale Avolio requested a motion for approval of final compensation payout for Officer #22835 in the amount of \$12,372.00. John Marshall made a motion to approve, seconded by Raymond Kendrick. Pasquale Avolio called for a motion to approve Chief Sicilia's request. George Allen made a motion to approve, seconded by Jason Bragunier. The aye vote was unanimous. Motion carried.
